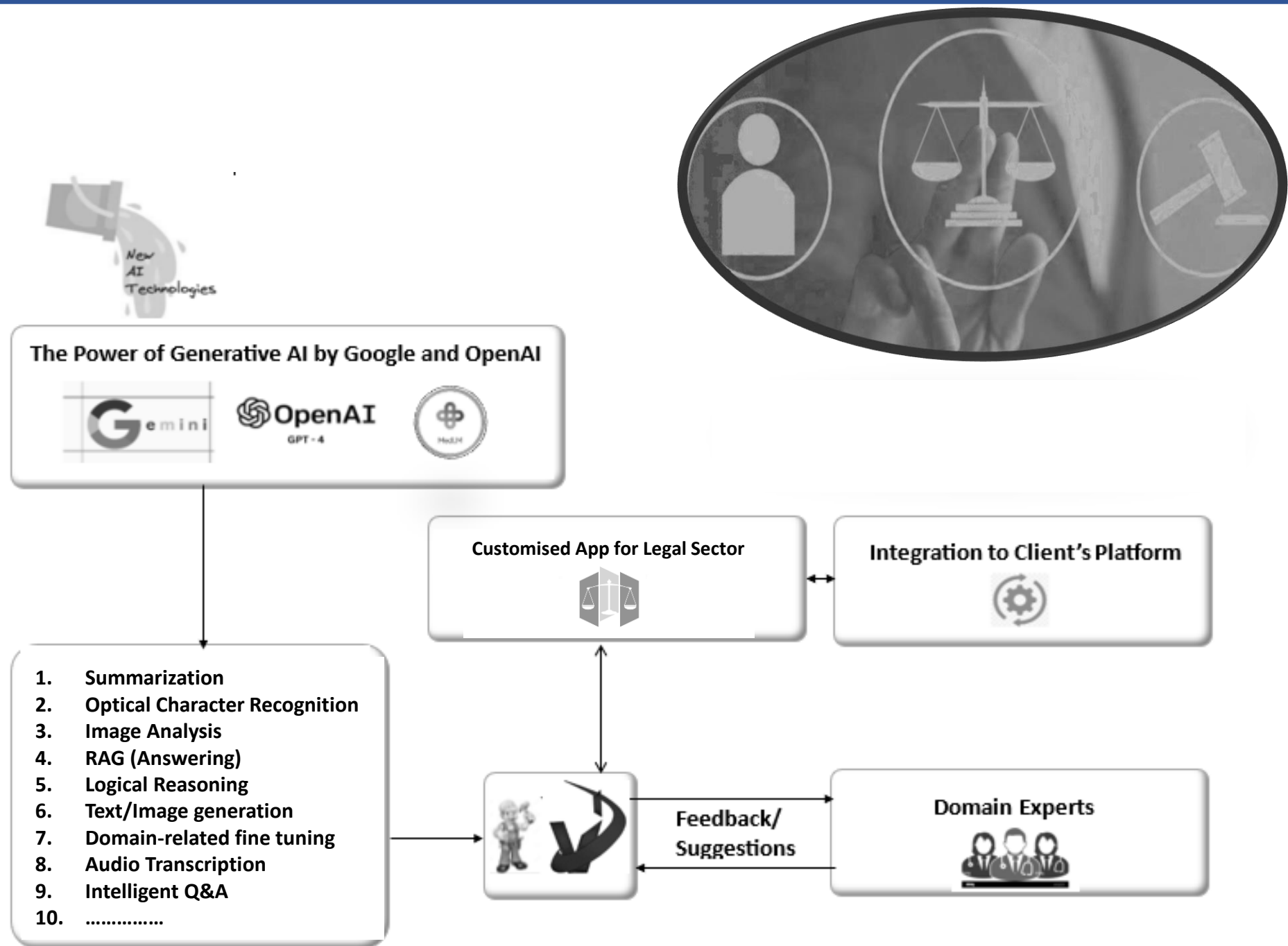

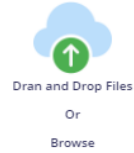

[11/19/10]: The Loan Agreement dated November 19, 2010, between the Republic of Belarus and the International Bank for Reconstruction and Development outlines a loan of \$150 million to finance the Road Upgrading and Modernization Project. The Project aims to reduce transport costs for road users on the M5 Road and introduce electronic tolling in Belarus. The agreement covers loan terms, interest rates, repayment schedules, project descriptions, implementation arrangements, procurement guidelines, and withdrawal conditions. The Borrower commits to carrying out the Project in accordance with the General Conditions and Project objectives. The agreement includes provisions for anti-corruption measures, safeguards, project monitoring, financial management, procurement methods, and loan disbursement. The Borrower's Representative is the Deputy Prime Minister of Belarus, and addresses for both parties are provided. The agreement is effective for 120 days after the signing date and includes detailed schedules for amortization, project execution, and withdrawal of loan proceeds. The Appendix defines key terms and modifications to the Anti-Corruption Guidelines. The agreement was signed in Minsk, Belarus, by authorized representatives from both parties.

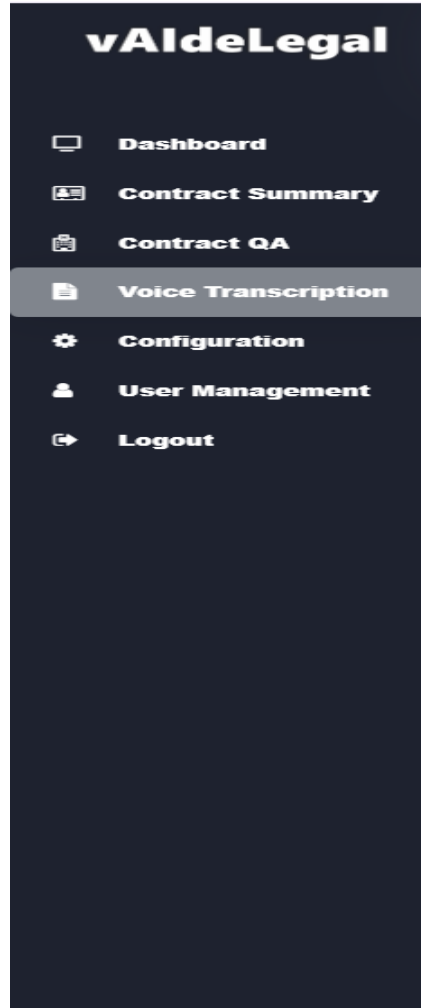

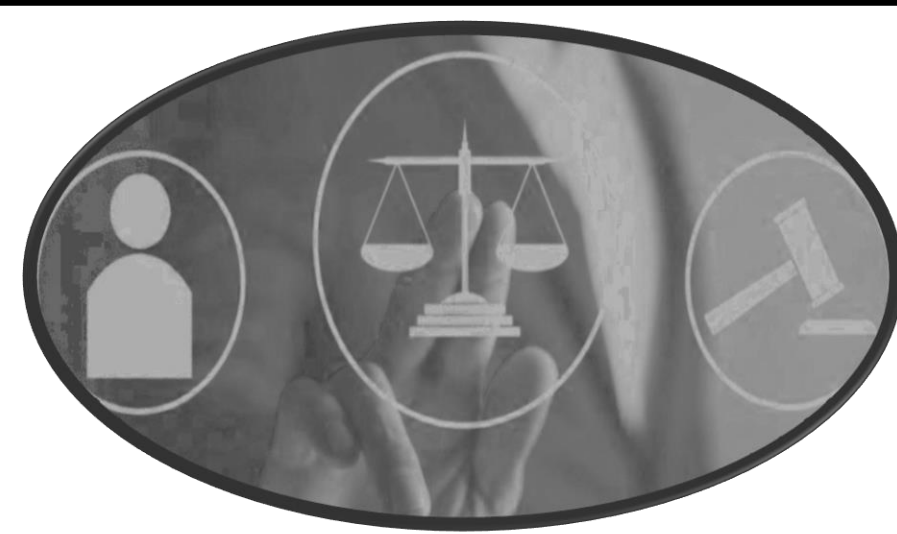
